The HMRC 'Approved Mileage Rate' for employee owned vehicles used for work journeys, has recently been increased by the Government from 45p per mile to 55p per mile, effective from 6 April 2026.

In line with this change, the Council is required to approve that its employee owned car mileage reimbursement rate will also increase accordingly. The increase will be effective from 6 April 2026, and any arrears owed to date will be paid in the July 2026 payroll.

Mileage incurred over 10,000 miles per tax year remains payable at 25p per mile.
